# PREPARATION OF THE SEIMAS FOR THE LITHUANIAN PRESIDENCY OF THE EU COUNCIL

### ON EUROPE DAY, THE OFFICE OF THE SEIMAS LAUNCHED A NEW WEBSITE



With 53 days left until the beginning of the Lithuanian Presidency of the Council of the European Union, symbolically, on 9 May – Europe Day, the Office of the Seimas launched a new website of the parliamentary dimension of the Lithuanian Presidency of the Council of the EU to Members of the Seimas, journalists and other information consumers. The welcome address by Deputy Speaker of the Seimas Petras Auštrevičius was followed by the contributions from Jonas Milerius, Secretary General of the Seimas, and Loreta Raulinaitytė, Director of the Communications Department and EU-

Presidency Coordinator. The new website, its structure and possibilities were presented by those who created the website.

The website of the parliamentary dimension of the Lithuanian Presidency of the Council of the EU <u>can be accessed</u> at **www.eu2013.lrs.lt** or **www.pirmininkavimas.lrs.lt**. The Presidency website is easy to find by clicking on the banner *Lithuanian Presidency of the Council of the EU. Parliamentary Dimension* on the main website of the Seimas.

The key task and novelty of the new website is a detailed presentation of comprehensive information about parliamentary dimension events and additional events related to the Lithuanian Presidency to be held in the Seimas. The calendar section will be continuously updated with all available information about events, including invitations, addresses made by participants, documents and photos. The website has a link to a watch live section, photo archives and audio-video archives.

The Presidency website contains a section *Consideration of EU Matters*, while a glossary of terms and concepts related to parliamentary activities in the Lithuanian, English, French and German languages will soon be uploaded too.

The new website provides key information, which was available on the previous website in Lithuanian, English and French: general information on the parliamentary dimension of the Lithuanian Presidency of the Council of the EU, various documents, press releases, the Presidency glossary, useful links, etc.

The new Presidency website (the old one, which was opened exactly a year ago, on 9 May 2012, is closed now) was developed by the Department of Information Technologies and Telecommunications and the Communications Department of the Seimas. Hopefully, the website will prove to be useful to everyone interested in the first Lithuanian Presidency of the Council of the European Union.

# THE SEIMAS COMMITTEE ON EUROPEAN AFFAIRS INFORMS THAT LITHUANIA PROPOSES TO ESTABLISH THE PARLIAMENTARY FORUM OF THE EU BALTIC SEA STATES



The Seimas Committee on European Affairs (CEA) proposes to hold the parliamentary forum of eight EU Baltic Sea States that would discuss the implementation, cooperation principles and future trends of the macro-regional European Union Strategy for the Baltic Sea Region (EUSBSR).

"In December 2007, the European Council, attended by me as Prime Minister, charged the European Commission with submitting the EU Strategy for the Baltic Sea Region by June 2009 at the latest. This initiative followed the Strategy on the Mediterranean Region. The EUSBSR was approved in October 2009. However, a political debate on the EUSBSR

was practically absent at the European level. The parliamentary dimension could fill this gap," said Gediminas Kirkilas, Deputy Speaker of the Seimas and CEA Chair.

#### **PARLIAMENTARY BUSSINES**

### ADOPTED AMENDMENTS TO THE INSURANCE LAW PREVENT THE INSURER FROM TREATING GENDER AS A RISK FACTOR IN LIFE INSURANCE



The Seimas has adopted amendments to the Law on Insurance (draft No. XIP-4723(2)), harmonising the Law with the judgement of the Court of Justice of the European Union delivered on 1 March 2011 in Case C-236/09.

The adopted amendments will prevent the insurer from treating the gender of an insured individual as a risk factor. The EU Member States are obliged to implement these provisions by the judgment delivered on 1 March 2011 by the Court of Justice which declared Article 5(2) of Council Directive 2004/

113/EC of 13 December 2004 implementing the principle of equal treatment between men and women in the access to and supply of goods and services providing an exemption for the use of sex as an actuarial factor in the calculation of premiums and benefits invalid with effect from 21 December 2012.

In 2011, the Law on the Good Faith Compensation for Immovable Property of the Jewish Religious Communities was passed, sending yet another positive signal. On 17 January 2013, the Seimas adopted the Resolution on the Proclamation of 2013 the Year of Remembrance of the Vilnius Ghetto to mark the 70<sup>th</sup> anniversary of liquidation of Vilnius Ghetto. We hope that it will help us build bridges from the painful past to our future", Gediminas Kirkilas, Deputy Speaker of the Seimas, said during the meeting with the members of the March of the Living delegation.

### MEMBERS OF THE LITHUANIAN, LATVIAN AND ESTONIAN PARLIAMENTS SIGNED THE JOINT DECLARATION ON THE AGRICULTURAL POLICY



On 12 April 2013 in Riga, the joint meeting of the Rural Affairs Committee of the Riigikogu, the Economic, Agricultural, Environmental and Regional Policy Committee of the Saeima and the Committee on Rural Affairs of the Seimas adopted the Joint Declaration on the Common Agricultural Policy of the European Union after 2013. The declaration notes that since the accession to the EU, Estonian, Latvian, and Lithuanian farmers have been receiving the lowest level of direct payments, which prevents them from enjoying equal opportunities within the European single market.

# VYDAS GEDVILAS, SPEAKER OF THE SEIMAS, ATTENDS THE CONFERENCE OF SPEAKERS OF THE EU PARLIAMENTS IN NICOSIA

"Inter-parliamentary cooperation in the European Union should be developed on the basis of the existing formats," stressed Vydas Gedvilas, Speaker of the Seimas, at the Conference of Speakers of the EU Parliaments held in the Cypriot capital of Nicosia.

At the Conference, the Speakers of Parliaments discussed the implementation of Article 13 of the Treaty on Stability, Coordination, and Governance (Fiscal Compact). Article 13 of the Treaty stipulates that "the European Parliament and the national Parliaments of the Contracting Parties will together determine the organisation and promotion of a conference of representatives of the relevant committees of the European Parliament and representatives of the relevant committees of national Parliaments in order to discuss budgetary policies and other issues covered by this Treaty." The Article underlines the cooperation between the national Parliaments and the European Parliament, which should play an important role in the process of economic coordination and governance in the EU.

According to Mr Gedvilas, the proposals on the implementation of Article 13 of the Treaty can be debated; however, the equality of all the Parliaments should be respected by focussing on effective cooperation and economically justified decisions.
