## EUROPEAN COMMISSION AND THE COUNCIL ARE CALLED ON TO SUPPORT ALL EUROPEAN LANGUAGES AND LINGUISTIC DIVERSITY



The Meeting of the Chairpersons of the Committees on Education, Science and Culture and the Committees on the Development of Information Society of the EU Parliaments entitled United in Diversity: Political and Social Development Aspects of EU Languages and Cultures was held in the Seimas on 27 September 2013. The Meeting was attended by representatives of the European Parliament and the European Commission; the participants of the academic conference of European linguists presented their findings. Session II of the Meeting focused on the problems and initiatives of digitalisation of

a language as a part of cultural heritage, the promotion of multilingualism in Europe and the importance of its presence in digital media.

At the end of the Meeting, the conclusions of Meeting of the Chairpersons of the Committees on Education, Science and Culture and the Committees on the Development of Information Society were adopted, which stress that due to the processes of globalisation and migration, the importance of knowledge of languages has particularly increased in today's European societies while language teaching has become one of the key objectives of EU language policy in the area of education.

### PARLIAMENTARY BUSSINES

### **AUTUMN SESSION WORK PROGRAMME PRESENTED TO MEMBERS OF THE SEIMAS**

The Seimas started its third (autumn) session. In his <u>welcome address</u>, Vydas Gedvilas, Speaker of the Seimas, invited Members of the Seimas to do their jobs qualitatively. "I ask each and every one of you to put greater focus on the quality, rather than quantity, of laws. If every draft law is sufficiently and as widely as possible discussed with society, public organisations and all stakeholders, legislation will no longer resemble the mass production of laws while laws of dubious necessity or in violation of the Constitution will not be adopted.

While presenting the Draft Resolution No XIIP-948 on the Work Programme of the Third (Autumn) Session of the Seimas as one of the key issues on the agenda of the first sitting of the regular session, Vytautas Gapšys, First Deputy Speaker of the Seimas, singled out the following areas to be covered by draft laws: stimulation of economic growth, increase of employment, reduction of poverty and social exclusion, financial sustainability of the country's economy and gradual increase of budget revenue, increase of energy efficiency and security, implementation of the policy on education, science and culture as well as on healthcare, strengthening of the security and defence policy, environmental protection, legal affairs, state administration, local authorities, agriculture, rural development and protection of human rights.

### ON 3 OCTOBER VYDAS GEDVILAS DISMISSED FROM OFFICE OF THE SPEAKER OF THE SEIMAS

At the plenary sitting of 3 October 2013 the Seimas decided to accept the resignation of Vydas Gedvilas, Speaker of the Seimas. The Seimas Resolution (Draft No XIIP-1058) on the Dismissal of the Speaker of the Seimas of the Republic of Lithuania was adopted by 76 votes in favour, 7 against and 35 abstentions.

"This is my decision and I would like no heated debate or passion. Nothing will collapse; it is just a change of speakers of the Seimas, which will not affect the work of the Seimas. I think that you all qualify for the post of the Speaker of the Seimas, anyone of you could be a Speaker. All that I ask you to do is to endorse my resignation," said Vydas Gedvilas requesting to dismiss him from office.

### LORETA GRAUŽINIENĖ ELECTED SPEAKER OF THE SEIMAS



Pursuant to its Statute, the Seimas of the Republic of Lithuania elected, through alternative voting, the Seimas Member Loreta Graužinienė as Speaker of the Seimas of the Republic of Lithuania. The Seimas Member Eugenijus Gentvilas was also nominated as a candidate for the office of Speaker. During voting by secret ballot, 125 voting papers were handed out and returned, 116 of them were declared valid and 9 invalid. The motion to appoint Ms Loreta Graužinienė as Speaker of the Seimas received 77 for votes while the nomination of Eugenijus Gentvilas was supported by 39 parliamentarians.

I hope that in 2016 it will make at least 1% of GDP," stated Vydas Gedvilas.

NATO Secretary General assured being positive towards Lithuania's efforts and recalled that investment was essential in guaranteeing the reliable

defence. "We are talking here about solidarity, and the investment obligation of all the Alliance's partners and finally about Europe's role and weight in the global context," said Anders Fogh Rasmussen.
