### Seimas overrode the President's veto on the new Labour Code

On 14 September 2016, the Seimas decided to override the veto imposed by Dalia Grybauskaitė, President of the Republic of Lithuania, on the draft of the new Labour Code (No XIIP-3234 Gr), and passed the returned draft legislation without amendments. The new Labour Code without the amendments proposed by the President of the Republic of Lithuania was adopted by 74 votes in favour, with 39 votes against and 10 abstentions.

The Seimas adopted the new Labour Code on 21 June 2016.

# Seimas approved the Law on the Legal Status of Aliens with the President's amendments included

On 14 September 2016, the Seimas approved the Law on the Legal Status of Aliens (draft No XIIP-4306Gr) returned to the Seimas for repeat consideration by a presidential decree. The Law was approved with all the amendments submitted by Dalia Grybauskaite, President of the Republic.

# Seimas approved the Law on Assisted Fertilization with the President's amendments included

On 14 September 2016, the Seimas agreed with the veto of Dalia Grybauskaitė, President of the Republic of Lithuania, on the draft Law on Assisted Fertilization (No XIP-2502 Gr) returned to the Seimas for repeat consideration.

The Law was adopted with all the presidential amendments. A total of 53 Members of Seimas voted in favour of adoption of the Law on Assisted Fertilization with all the proposals made by the President of the Republic, with 40 votes against and 8 abstentions.

## Seimas to consider legal regulation on entry of 'dirty' electricity to Lithuania

On 10 September 2016, in accordance with their right of legislative initiative, citizens of the Republic of Lithuania submitted a draft Law on Protection of Electricity System and Electricity Market (No XIIP-4639) to the Seimas for consideration.

The submitted legislation proposes to establish the general principles, conditions and stages for protecting the electricity system and electricity market of the Republic of Lithuania from entry of 'dirty' electricity generated by unsafe power plants in third countries.

The draft Law provides that the power plants under construction or in operation in third countries would be treated as unsafe when, due to their geographical location or technological features, they pose a threat to the Lithuanian capital city of Vilnius or a large share of the population of the Republic of Lithuania living in a particular area of the country and, in the event of any threat, the people living in areas such as Vilnius would have to be evacuated.

## Seimas to open discussion on cutting the number of MPs

On 20 September 2016, the Seimas decided to consider draft amendments to Article 55 of the Constitution of the Republic of Lithuania (Draft No XIIP-4706) submitted by Valentinas Bukauskas, Member of the Seimas Labour Party political group, who proposed reducing the number of lawmakers from 141 to 111.

## Seimas adopted new version of the Law on Support in Case of Death

On 20 September 2016, the Seimas adopted a new version on the Law on Support in Case of Death (draft No XIIP-4320(3)) in compliance with the European standards. The Law established the legal framework for the provision of support for repatriation of mortal remains of Lithuanian citizens deceased abroad, the basis and conditions for granting this support, and the size of the allowance. The Law also ensured proper compatibility of the Lithuanian legislation with the requirements established in the EU law. Other amendments to the Law result from the analysis of the problems arising in the application of the Law in practice.

#### **SPEAKER OF THE SEIMAS**

Speaker of the Seimas: Joint strategic infrastructure projects will ensure further integration between the Baltic States and Western Europe



On 8 September 2016, at the 26th Economic Forum held in Krynica Zdrój, Poland, Loreta Graužinienė, Speaker of the Seimas, noted the need to deepen regional integration between the Baltic States and Central Europe through joint strategic infrastructure projects, thereby ensuring economic and energy security of our countries.

In taking the floor in the Plenary Session titled *What Kind of* 

*Solidarity Does Europe Need*?, the Speaker of the Seimas pointed out that in order to further strengthen the integration between the Baltic and Central European regions, it was essential to continue developing strategic transport and energy infrastructure projects between Lithuania and Poland and to move towards synchronisation of the Baltic power grids with the continental European network.

# Committee on Foreign Affairs: Lithuania supports the ambitious free trade agreements with the US and Canada

# Meeting of Chairpersons of the Committees on EU Affairs of the Lithuanian, Latvian, Estonian and Polish Parliaments in Tallinn



On 8–9 September 2016, an informal meeting of Chairs of the Committees on EU Affairs of the Lithuanian, Latvian, Estonian and Polish Parliaments took place in Tallinn. Among other topics, the participants discussed the agenda of the Conference of Parliamentary Committees for Union Affairs (COSAC) due to take place in Bratislava (Slovak Republic) on 13–15 November 2016; reinforcement of the role of national Parliaments in the EU decision-making process; and progress of the EU–US negotiations on the Transatlantic Trade and Investment Partnership (TTIP). During their visit, the

parliamentarians met with Taavi Rõivas, Prime Minister of Estonia, and held an exchange of views on the future of the EU after Brexit.

Welcoming the participants, Gediminas Kirkilas, Chair of the Committee on European Affairs, noted that Lithuania supported the initiative and stressed that "the time has come to strive for economic growth not only by concentrating on financial and innovation sectors,

but also by turning to a social dimension, including social welfare of the citizens."

The aim of the discussion was to consider how to develop the European Pillar of Social Rights, exchange ideas and gather public views on the most pressing economic and social problems in Lithuania, and how the European Pillar of Social Rights could help to address these issues.
