

UKRAINE REFORM CONFERENCE VILNIUS, LITHUANIA JULY 7-8, 2021

The Conference

On 7-8 July 2021, the international "Ukraine Reform Conference" (URC) will take place in Vilnius. Lithuania and Ukraine will co-host it. It will be the fourth conference of this kind following such forums in London (2017), Copenhagen (2018) and Toronto (2019).

The Vilnius conference will be forward-looking. The event will bring together Ukraine and its international partners with the aim to discuss achievements in reforms implementation, to consolidate support for reforms in the country towards strengthening the country's resilience and realising the "Ukraine 2030 Strategy" ensuring continuation, sustainability and consistency of the reform process. The conference is also an opportunity for Ukraine's partners in the international community to reconfirm support for the country's independence and vision of the future, as well as to show solidarity with the Ukrainian people.

As in the past, the URC will bring together prominent delegates, including political leadership, from the European Union and NATO member states and institutions, other international organisations and partner countries, as well as top-minds of Ukraine's civil society organisations, the business community, think tanks, media and the Ukrainian diaspora.

Against the background of the COVID-19 pandemic, the URC is expected to be held in a hybrid format. The meetings will take place in Vilnius in combination with and online participation of the delegates and guests.

Working languages at the Conference will be English and Ukrainian.

The Context

Following the landmark parliamentary and presidential elections in 2019, the Ukrainian political leadership has set out an ambitious reform package focusing on the modernisation of the country, its international integration, and the Ukrainian people's well-being. The course towards these objectives continues to be firm and steady despite the impact of the COVID-19 pandemic, Russia's illegal annexation of Crimea, its continuing aggression in eastern Ukraine, and the further undermining of Ukraine's security.



Democratic, secure, pro-market and based on the rule of law European Ukraine is where the aspirations of Ukrainian people, the vision of the country's political leadership and the interests of the democratic international community meet. The success of Ukraine is a global interest. With this insight, the country has embarked on structurally complex and politically challenging transformational reforms in the governance, economic and social spheres.

Furthering market economy, strengthening the resilience of the society, European and Euro-Atlantic integration, consolidating democracy and the rule of law, as well as combating corruption are in the package of reform-oriented development agenda. These broader objectives entail specific reforms in such areas as the judiciary, decentralisation, privatisation, the reform of SOEs, land market reform, public administration reform, ensure independence and effective functioning of anti-corruption institutions, re-criminalisation of illegal enrichments, energy sector reform, security and defence sector reform and others.

These reforms are set out in the "Ukraine 2030 Strategy" and other policy statements of the country. Contributing to shaping the reform agenda and supporting its realisation is part of the international community's response and partnership with Ukraine.

The URC in Vilnius will provide a platform for all Ukrainian stakeholders - international partners, central and regional authorities, civil society, business, experts and donor communities - to discuss the reform vision, objectives, strategies and further mutual cooperation.

Setting the stage

On July 7, the President of Ukraine Volodymyr Zelensky, is expected to give a key-note address setting the stage for discussing "Strong Ukraine in a stronger European and Euro-Atlantic Family".

- Following the President's address, the participants will be encouraged to look beyond the horizon of today in discussing their vision of the future. Specifically, in the first discussion of the event 'EU-Ukraine cooperation agenda' the speakers and participants will elaborate on the progress, challenges and further steps in Ukraine's European integration path and emerging agenda of cooperation within various frameworks, including implementation of the EU-Ukraine Association Agreement, rule of law and anticorruption, involvement of Ukraine in the European Green Deal.
- In the second part of the day, the focus will be on 'Security and Defence Sector Reforms'
 in Ukraine and the region. The theme of building resilience is vital to Ukraine and its
 international partners in the context of ongoing Russian threats and hybrid warfare
 against Ukraine. These cyber, disinformation and other attacks aim to plant mistrust and
 fear in the population, weaken the country's social fabric, and trust its political stability
 and leadership as well as international credibility. Cybersecurity, countering hybrid



threats and disinformation, defence sector reforms and Ukraine's NATO integration will be discussed.

The impact of the COVID-19 on Ukraine and ways to address the negative consequences will also be discussed. Since the pandemic, the Ukrainian economy fell into recession, contracting by 4.4% in 2020. The public finances deteriorated (5.5% deficit and 63% of GDP of public debt). Ukraine's foreign trade in 2020 was also affected by trade restrictions imposed due to the coronavirus pandemic, global decline in demand and a fall in prices in world commodity markets. The Covid-19 pandemic particularly strongly affected eastern Ukraine and its high portion of vulnerable citizens on both sides of the contact line.

On July 8, the Conference will focus on "Reform Agenda – Priorities Ahead" with the Prime Minister Denys Shmyhal outlining in detail the Ukrainian reform strategy 2030. This will be followed by two deep-dive panel discussions on specific reforms:

- The first session will focus on objectives, challenges and steps towards improving the business environment and investment climate and corresponding market deregulation, implementation of the land reform, the SOE reform and privatisation, the further transformation of the banking sector, and other sector reforms. Opportunities for regional and international political and economic cooperation, especially those emerging from the European Green Deal, will be discussed in the above context.
- The second session will address underlying governance challenges and the corresponding reform agenda. In particular, the reforms of public administration, public financial management, decentralization, digitalization and e-governance will be discussed, emphasizing actions needed in number of areas to maintain consistency and sustainability of the process.
