## PROCESSING OF FACIAL IMAGES AND VOICE DATA OBTAINED BY PHOTOGRAPHING AND/OR FILMING

This privacy notice shall be addressed to persons who, in the course of various events or events related to the activities of the Seimas or the Office of the Seimas, get captured on photo or video camera and whose personal data are processed by the Office of the Seimas for the purposes listed below.

**PURPOSE**  
(Why do we use your data?)

To inform the public about the work of the Seimas, to ensure transparency of the Seimas' activities, to implement the principles of openness and transparency applied for the state politicians in public life, to promote activities of the state institution and to inform the public about the events or happenings related to the activities of the Seimas or the Office of the Seimas as well as to record historical moments of activities of the Seimas and the Office of the Seimas.

**CONDITION FOR LAWFUL PROCESSING**  
(On what basis do we process your data?)

During the events related to the activities of the Seimas or the Office of the Seimas, photographing and/or filming shall be in compliance with the legal obligation (Article 6(c) of the General Data Protection Regulation (GDPR), laid down in the following pieces of legislation:

- The Law on the Provision of Information to the Public,
- The Law on the Right to Obtain Information and Re-Use of Data,
- Regulations of the Office of the Seimas,
- The Law on the Approval, Entry into Force and Implementation of the Code of Conduct for State Politicians;
- Other legal acts providing for the obligation to ensure transparency of institutional activities.

Photos may be taken and/or filming may also take place on the basis of legitimate interest of a state institution to promote its activities, to mobilise the community of the Seimas and the Office of the Seimas on the basis of the legitimate interest of the public to be informed about the activities of the Seimas or the Office of the Seimas. (Article 6(f) of the GDPR).

Where non-public figures are invited to participate in specific activities for the promotion of the institution and the Office of the Seimas intends to use and make available to the public the photo and/or video footage obtained during such activities, such processing of personal data shall be carried out on the basis of the consent given by these persons. (Article 6(a) of the GDPR).

**PERSONAL DATA**  
(What personal data are processed?)

### **GENERAL DATA**

Data identifying a natural person: first name, surname, position (where identification of the person is possible and facial images are described). Other data: contact details (where necessary for the organisation of photographing or filming activities), facial image(s), voice data, data relating to participation in an event or other activities which are photographed or filmed.

SOURCE OF DATA (Where do we get your data?)	The Office of the Seimas obtains your data directly from you.
ACCESS TO DATA (Who will have access to your data?)	<p>Photos and videos of events may be published on the websites and social media accounts of the organisers of events, disseminated and published in the media when providing information about the activities of the institution; Law enforcement institutions, courts, and etc. (where provided for by law and where provision of personal data is necessary and proportionate for legitimate and specific purposes).</p> <p><b>DATA PROCESSORS (Insofar as they provide specific services to the office of the Seimas)</b> Where necessary, enterprises providing services to the Seimas TV channel and Seimas social media accounts.</p> <p><b>THIRD COUNTRIES (all non-EU Member States or non-EEA States)</b> Provision of personal data to third countries is not intended.</p>
STORAGE PERIOD (How long will we store your data?)	The data shall be stored for as long as it is necessary to prepare the material needed for the activities of the Seimas or the Office of the Seimas, then transferred to the Archives and kept permanently for historical purposes.
EXERCISE OF DATA SUBJECTS' RIGHTS (What are your rights and how can you exercise them?)	<p>As a data subject, you have the right to apply to the Office of the Seimas regarding the processing of your personal data, that is, you have the right to the following:</p> <ul style="list-style-type: none"> <li>• right to information on data processing (Articles 13 and 14 of the GDPR);</li> <li>• right to access the data (Article 15 of the GDPR);</li> <li>• right to rectification (Article 16 of the GDPR);</li> <li>• right to request erasure ('right to be forgotten') (Article 17 of the GDPR). Note: This right may be exercised provided at least one of the conditions set out in Article 17(1) of the GDPR is fulfilled;</li> <li>• right to restrict data processing (Article 18 of the GDPR). Note: This right may be exercised provided at least one of the conditions set out in Article 18(1) of the GDPR is fulfilled;</li> <li>• right to object to your personal data processing (Article 21 of the GDPR). Note: In this case, you should indicate for what specific reasons you wish to exercise these rights (only applicable where data are processed in accordance with Article 6(1)(e) and (f) of the GDPR);</li> <li>• right to data portability (Article 20 of the GDPR); Note: This right may be exercised when personal data are processed on the basis of consent and by automated means.</li> </ul> <p>Applications must be submitted to the Office of the Seimas in writing and in electronic format, and must allow for identification of the applicant and the data subject. The identity of the data subject will be established by means of an identity document or by electronic communication tools allowing for proper identification. An application submitted by e-mail must be electronically signed. Where information is requested by a person's representative, the representative must produce proof of representation.</p> <p>Regarding the procedure for exercising the rights of data subjects, please contact the Data Protection Officer by using the contact details indicated above.</p>
WITHDRAWAL OF CONSENT (Can you withdraw your consent when the data processing is based on consent?)	When you are invited as a non-public figure to take part in a specific activity of promoting the institution and the Office of the Seimas intends to use and make available to the public the photos and/or video footage made during the activity on the basis of your given consent, you shall have the right to withdraw your consent at any time by submitting a request by e-mail: <a href="mailto:ikd@lrs.lt">ikd@lrs.lt</a> or by arriving in person at the Seimas at the above mentioned address.

In other cases, during events or events related to the activities of the Seimas or the Office of the Seimas, your facial image is managed on the other basis indicated above rather than by the consent; therefore this right is not applicable to the processing of such personal data.

SUBMISSION OF  
COMPLAINTS  
(When can you submit a  
complaint about the  
action/omission of the  
Office of the Seimas?)

Please be informed that you are entitled to complain to the State Data Protection Inspectorate and the court over the action/omission of the Office of the Seimas in accordance with the procedure laid down in legal acts, as well as to appeal to court against the action/omission of the State Data Protection Inspectorate.

Before submitting a complaint to the appropriate institution, please contact the Data Protection Officer of the Office of the Seimas by using the contact details indicated above.

DO YOU HAVE TO PROVIDE  
YOUR DATA?

If you participate in the events related to the activities of the Seimas or the Office of the Seimas during which photos are taken and/or filming takes place and in which you participate together with state politicians or candidates for state politicians and other public figures, your facial image, if you are captured on photo or video will be used for the above mentioned purposes and may be made public.

In the course of other events, you may express your objection to being photographed or filmed by a gesture and orally to the photographer or operator. You may also express your objection after familiarising yourself with the video material obtained during the event.

Please be informed that your data will not be used for making decisions concerning yourself based on automated data processing, including profiling.
